CALCLEAR HYDRO 80 WITH PREWOUND PIPE Installation pages – PLEASE READ WARRANTY

The CALCLEAR Water Conditioners create an EMF generated through antennae wrapped around the internal (white) pipe. Computer generated signals transmitted by the electronic controller treat the flow of water resulting in any minerals remaining in solution and reducing scale formation on the pipe and the downstream plumbing fittings and equipment using the treated water.



Installation is recommended in ground. Above ground installation requires metal supports.

Step 1- Check all parts have been delivered

- ❖ 1 off Controller with power lead attached
- ❖ 1 off Prewound pipe with two antennae leads coming from conduit hole on end of pipe

Step 2- The CALCLEAR pipe is ID 80 mm diameter and 1.5 metres long. 1.5A DC The outside pipe is a protection for the internal windings. Install the prewound pipe inline in the water pipe. The inlet pipe may be smaller than the CALCLEAR pipe and flanges may be necessary to adapt to customer's existing pipe .(see picture B)

The outlet conduit hole is at one end but the pipe can be installed in either direction to suit.

Step 3- Once pipe is installed, connect 2 antennae to CALCLEAR electronic controller (no specific plug hole is required) and tighten the PLUG fittings to secure.

Step 4- Connect power lead and turn on. Lights will flash RED , then RED/ GREEN and then GREEN. This ensures that the signal is operating correctly. If lights are RED and do not go through this process then please contact CALCLEAR.



If at any stage the lights go RED contact us and report the error.

1. CALCLEAR Investments Pty Ltd warrants, the Water Conditioner will, when installed in a protected covering from the elements and used properly according to the instructions provided to the purchaser and authorised by CALCLEAR, cause fresh water to become softer by reducing the size of the mineral particles in that water by limiting the crystallisation of those particles.

2. CALCLEAR treatment **does not create potable water**. CALCLEAR softens and reduces scale formation.

3. To the full extent permitted by law, all other warranties and implied terms are excluded from application in respect of the Water Conditioner. Without limiting the foregoing, CalcClear Investments Pty Ltd makes no warranty; (a) as to the effect which the Water Conditioner may have on pipes, irrigation systems, plumbing fittings, plants, appliances, equipment or machinery which are faulty or worn or which have been improperly installed. Or (b) that bore/ well water treated by the CALCLEAR Water Conditioning System facilitates irrigation only by the reduction of particle size of the minerals in the flow and by inhibiting crystalline formation. CalcClear Investments Pty Ltd makes no warranty as to the effects on the soil, plantlife or any other lifeform of any accumulation of the said treated water particles.

4. CalcClear Investments Pty Ltd further warrants that it is the responsibility of the purchaser, or in the case of trials or evaluations the person in whose care, the CALCLEAR Computerised Water Conditioner is left, to ensure that any scale dislodged, by the proper operation of the CalcClear System, in pipes, filters and all equipment aforementioned, is removed from the water flow. CalcClear Investments Pty Ltd accepts no liability for any damage, malfunctions, downtime, production losses, repair costs, blockages, water starvation or leaks or any associated damage which result from the design function of the CalcClear Computerised Water Conditioner. The system is designed to keep mineral particles in solution to create softer water and progressively descale built up minerals in water systems to which they are connected.

5. CalcClear Investments Pty Ltd cannot accept responsibility for use of the CalcClear Units on asbestos cement pipes, or on fittings, tanks or other apparatus where scale build up contributes to the water retaining ability.

6. CalcClear Investments Pty Ltd accepts no liability for any loss or damage caused by theft, fire, flood, storm, lightning, or other destructive events, misuse, wear and tear, neglect, incorrect adjustment or repair, for damage caused by installation, adaption, modification or use in an improper manner or inconsistent with the technical and/or safety standards required in the country where the appliance is used.

7. The sole and exclusive remedy available under this warranty is for the replacement of a CalcClear Unit or any defective part or parts of a unit within 12 months of original purchase, and no other remedy, including, but not limited to incidental or consequential damage or loss of whatsoever nature shall be available to the purchaser.

8. This Warranty is only valid if an **appropriate surge protector** is fitted to account for surges in power supplies.

9. WARRANTY IS VOID IF CALCLEAR UNIT IS TAMPERED WITH OR OPENED

10. Money back guarantee- Two weeks from arrival of goods is allowed for installation. 3 month money back term is guaranteed if the CalcClear does not perform the task for which it was purchased.
